


WE PREPARE FAMILIES TO BE SUCCESSFUL HOMEOWNERS THROUGH EXTENSIVE PRE AND POST-SALE FINANCIAL, SOCIAL, HOME-MAINTENANCE AND OTHER SUPPORT SERVICES. IN FY21 WE COMPLETED 9 NEW HOMES AND 4 RECYCLES, AND WORKED ON THE PRE-DEVELOPMENT OF 18 ADDITIONAL NEW HOMES. ONGOING COVID-19 CONCERNS REDUCED VOLUNTEER SERVICE HOURS BY OVER 50% FROM FY20 AND 70% FROM BEFORE THE PANDEMIC.

NET PROCEEDS GO TO FURTHER THE MISSION OF PATERSON HABITAT FOR HUMANITY. THE BENEFITS TO THE COMMUNITY ARE TWOFOLD; FIRST THAT WE OFFER LOWER-PRICED ITEMS FOR SALE, AND SECOND THAT WE REUSE OR RECYCLE ITEMS WHICH WOULD OTHERWISE HAVE TAKEN UP SPACE IN A LANDFILL.
